# State Grants Help Reduce Costs & Replace Aging Equipment

Using state competitive grants, Liberty has received \$275,000 to replace the fire alarm systems, HVAC controls, and inefficient lighting in both schools. The fire systems and controls used in heating and cooling the two buildings were aging quickly, and occasionally the fire system sent students and staff outside for unplanned fire drills.

General Fire received the contract to retrofit the schools with new alarms, strobes, and master control boards. Work on the fire systems was completed in May with additional work on magnetic door releases and dampers finished over the summer break. The new fire systems have eliminated the false alarms and interruptions in instruction.

DIVCO of Spokane will finish the installation of new HVAC controls in August before the first day of school. The previous system was getting so outdated, the only way to find replacement parts was to look on eBay for used parts that had been removed from older buildings being upgraded. The old controls served the community well by outlasting their estimated lifespan.

The last and quite possibly the most exciting project has been the replacement of all our inefficient lighting in both buildings. The elementary/junior high school gym lighting has been substandard from the beginning, but with the new T5 florescent systems, the gym is bright and full of light for the first time. The high school gym has the same lighting system, which will use 50 percent less energy than the old system. The new lighting is also able to be turned off and back on without a delay.

Through the use of these funding sources, our junior high gym fills the space with bright light. district eliminated the need to go to the community with a bond to replace this critical equipment.

The Ironman competition combines a 2.4 mile swim, 112 miles of cycling, and finishes with a full 26.2 mile

marathon run.

## **Junior Boosters Provides Elementary with Grass Playfield**

The Liberty Junior Boosters volunteer parent group has provided over \$100,000 in support of K-8 education over the past twelve years. Their motto "Making a Good School Great" has been a theme that has supplied instructional technology to all classrooms and provided assistance in the purchase of extracurricular equipment. Last year the Junior Boosters organized and conducted a Sports-A-Thon to raise money in part to build a grass playfield on the elementary playground. Through pledges our students raised

playground. Through pledges our students raised soccer goals, shooting baskets and running laps, a result the field has been engineered, leveled, irrigated, and seeded. An additional \$4,000 was provided by a grant from Trans Canada to complete the project. The automated sprinkler system installation and hydro seeding were completed in early August. By mid- to late September, elementary students should have a brand new grass field to play on during recess.

#### **JH ASB Fees**

All seventh and eighth grade students are required to purchase an Associated Student Body (ASB) card for \$20 in order to participate in the ASB-supported activities that take place throughout the year. Those students participating in extra-curricular sports or band also pay an additional one-time \$20 fee, for a total of \$40. These funds go toward purchasing equipment and uniforms as well as costs for officials and entry to special events. Sixth grade athletes who participate in junior high athletics are also required to pay both fees.

## **Full-Day, Every Day Kindergarten**

Liberty kindergarten will return to full-day, every day this fall through additional funding provided by the M&O levy that passed last winter. The state only funds half-day kindergarten unless a school is in a very high poverty area. Liberty does not qualify for this additional funding.

Kindergarten is a critical year academically as youngsters begin learning to read, write, and work with basic numbers. They also learn important social skills like working in groups, sharing with large numbers of new friends, and working independently in the classroom. Research data shows us that students in a full-day kindergarten program do

much better in grades one and two, especially if they come from a low-income family.

## Junior High Schedule Adds A.M. Nutrition Break

Last spring our junior high students and staff test-piloted a 10-minute morning nutrition break between first and second periods. This new plan will be implemented at the beginning of the school year by starting the junior high school day five minutes earlier at 8:15am and holding a break for students from 9:05-9:16 daily. During this time junior high students may work with a teacher or go the cafeteria for breakfast or a snack. This schedule model is a direct reflection of the high school nutrition break, which has been in place for the past two years. The change also serves to better align the junior high and high school schedules for students taking classes in both buildings.

**Closed Campus** Liberty High School maintains a closed campus. Students finding it necessary to leave school during the school day shall check out through the office. The student check-out must be authorized by a parent or guardian. Students wishing to leave campus with another student must have parent/guardian consent from both students' legal guardians. Authorization shall be in the form of a signed parent/guardian note or by parent/guardian personal contact with the office. Failure to check out or provide proper authorization for leaving campus will constitute a violation of school rules even if the absence is valid. These rules are in place to ensure the safety of our students.

**Field Trip Permission** We will be sending out permission forms; please return these to the office at your earliest convenience. Students will not be allowed to leave on any field trips without these on file due to liability issues.

**Student Handbook** Each student will receive a student handbook on the first day of school. Please look through the handbook with your student, as there are a few changes from last year. Also, each student will be required to sign a notice of understanding, which needs to be turned in to the office.

**Change of Address** We ask that you notify the LHS office if you change your address, email address and/or phone number. It is vital to us that we be able to reach you; we are in the process of updating our records.

**Gym Floor** The gym floor has been refinished again this summer. It is important to keep our facilities looking neat and clean. Everyone is encouraged to use appropriate shoes on the floor. Also, during athletic contests or other events in the gym, the floor is to be used only by those participating in the events. Please stay off the gym floor before, during, and after each contest or event. Thank you.

#### **Meal Prices for 2012-13**

Children from families whose income is at or below the levels shown are eligible for free or reduced-price meals.

Application forms, with a letter to parents or guardians, will be sent to all homes at the beginning of the school year. To apply for free or reduced-price meals, households must fill out the application and return it to the school. Additional copies are available at the principal's office in each school. The information provided on the application will be used to determine eligibility and may be verified at any time during the school year by school or other program officials.

For school officials to determine eligibility, households must provide the following information listed on the application: the names of everyone in the household, the amount of income each household member received last month and where it came from, the signature of an adult household member, and the last four numbers of that adult's social security number. If the adult signing the application does not have a social security number, check the "I do not have a social security number" box. For a child who is a member of a Basic Food household or Temporary Assistance for Needy Families (TANF) assistance unit, the household need provide only the child's name, the Basic Food or TANF, or FDPIR case number, and printed name and signature of an adult member on the application.

The Department of Social and Health Services (DSHS) will download the names of all children age birth to 20 into the Office of Superintendent of Public Instruction (OSPI) Comprehensive Education and Data Research System. Information will include the child's first name, last name, middle initial, and date of birth. Upon receipt of this Applications may be submitted at any time during the school year.

Under the provisions of the free and reduced-price policy, the designated approving official(s) will review applications and determine eligibility. Parents or guardians dissatisfied with the ruling of the official may wish to discuss the decision with the approving official on an informal basis. Parents wishing to make a formal appeal may make a request either orally or in writing to the fair hearing official, Bill Motsenbocker, District Superintendent, for a hearing on the decision.

Foster children are also eligible for free meals regardless of personal use income. If you have questions about applying for meal benefits for foster children, contact the school or district office. The information provided by the household is confidential and will be used only for the purposes of determining eligibility and verifying data.

#### Asbestos Hazard Emergency Response Act (AHERA)

As a result of the 2010 AHERA threeyear re-inspection, the following known or assumed asbestos-containing building materials (ACBMS) have been identified in the Liberty High School.

Non-Friable ACBM:

- Floor tile and mastic (closets, beneath built-in cabinets)
- Pipe joints, elbows and tees (above ceilings and behind walls-showers, restrooms, Home Economics classroom, laundry room, custodial closets, science rooms)

Friable ACBM:

None

All ACBM listed above were found to be in good condition and are being continually maintained in accordance with all Washington State and federal laws.

Note: In compliance with the US Environmental Protection Agency (EPA) Asbestos Hazard Emergency Act (AHERA), Liberty School District contracted with Educational Service District 101 of Spokane, Washington, to conduct the Three-Year Asbestos Reinspection of all school buildings. During January 2010, an EPA accredited asbestos Inspector and Management Planner performed the required inspection, reassessed each category of asbestoscontaining building materials (ACBM) and noted any significant changes from the previous inspections. Re-inspection will assist the school district in the process of safely managing each ACBM within our district.

The AHERA Re-inspection Report and Management Plans are available to the general public and can be reviewed anytime during normal school hours. As required by AHERA, a designated person is available during regular business hours to answer any questions concerning ACBM in our building. The designated person can be contacted through the district office.

#### **Liberty Sets Childfind**

Liberty School District provides many programs for children in our schools at no cost to you! The schools offer programs such as speech therapy, physical and occupational therapy, Title/LAP special education academic programs, and preschool classes for children three years and older. Developmental screenings and/ or comprehensive assessments for children who are suspected of having a disability which could adversely affect their educational development are available at no cost to you. These services are available for persons between the ages of birth through 21 years of age. The screenings are held monthly appointment only. Liberty will be screening 3-to-5 year olds this fall. # Student Responsibilities and Rights Policy

Copies of Liberty School District's Student Rights and Rules Governing Student Misconduct Policy are available upon request at all district school buildings. Copies will be distributed to all secondary students at the beginning of the school year.

#### **Student Privacy**

The district is prohibited from releasing any personally identifiable records or files about an individual without written parental consent. However, the district may release a list of students belonging to a group (e.g. graduating seniors, etc.). A student's name will be excluded from a listing of students upon written request by a parent. The information on a list may include:

- A. The student's name, address and telephone number;
- B. Date and place of birth;
- C. Major field of study;
- D. Participation in officially recognized activities and sports;
- E. Weight and height of athletic teams;

- F. Dates of attendance:
- G. Degrees and awards received; and
- H. The most recent previous educational agency or institution attended by the student.

The district may also release photographs of students for public information purposes.

Parents have the right to request that any or all of these categories of information, including personally-identifiable photographs, not be released without their prior consent. This request must be given in writing to the student's principal.

#### **Pesticide Notification Policy**

The state legislature House Bill 1451 requires school districts to notify the public of pest control and herbicide use. Any interested person can register with the school district to receive notification of pesticide application or can contact us for any information on our Integrated Pesticide Management Plan. Our plan is available for review at the district office. The district will post notices at the application sites and notify prior to applying. For more information, contact Rick Brash at 624-4415.

#### **Nondiscrimination/Title IV**

The Liberty School District complies with all federal and state rules and regulations and does not discriminate on the basis of race, creed, color, national origin, families with children, sex, marital status, sexual orientation, age, or the presence of any sensory, mental or physical disability or the use of a trained dog guide or service animal by a disabled person. This holds true for all employees as well as students who are interested in participating in educational programs and/or extracurricular school activities. Inquiries regarding compliance and/or grievance procedures may be directed to the school district's Title IX Officer, Blaze Burnham, and/or Section 504 Coordinator at 509-624-4415.

#### **Dangerous Weapons Policy**

It is a violation of state law for any person to carry a firearm or dangerous weapon on

school premises, school-provided transportation or areas of other facilities being used for school activities. The law outlines exceptions in certain cases, i.e., security activities, firearm safety lecture/courses, law enforcement officers, etc.

#### Smoking Prohibited

Smoking or any other use of any tobacco products is prohibited on school district property. This includes all district buildings, grounds and district-owned vehicles.

#### **Drug-Free Schools**

Drugs, alcohol and schools do not mix. Schools are required to meet certain guidelines; patrons are hereby notified of Liberty School District's policy. Liberty School District supports abstinence from alcohol and other drugs for all students in order that their development can reach full intellectual, emotional, social, and physical potentials.

# **Guidelines for Children with Life-Threatening Conditions**

Washington law defines a life-threatening condition as "a health condition that will put the child in danger of death during the school day if a medication or treatment order and a nursing plan are not in place." Children with life-threatening conditions such as severe bee sting or food allergies, severe asthma, unstable diabetes, severe seizures, etc., are required to have a medication or treatment order and nursing plan in place before they start school. The medication or treatment order must be from the child's licensed healthcare provider.

If a medication or treatment order is not provided, the chief administrator of the school is required to exclude the child until such order has been provided. Our exclusion procedures are in accordance with the rules (WACs) of the State Board of Education. If your child has a lifethreatening condition that may require medical services to be performed at

school, you must immediately notify your school's nurse. The necessary forms will be provided, and a time will be arranged for you to meet with your child's school nurse. Please call Sarah Beyersdorf at 245-3211 with questions.

#### **Homeless Assistance**

Students who become homeless may receive assistance to remain at their school and receive other assistance. Please contact the school counselor or Cyndi Freeman, Homeless Liaison, at 245-3211 x 2217.

#### **No Child Left Behind Act**

The Federal No Child Left Behind Act of 2001 requires school districts that receive federal Title I funding to notify parents of their right to know the professional qualifications of the classroom teachers who instruct their children. As a recipient of these funds, Liberty School District will provide you with this information in a timely manner upon request.

Specifically, you have the right to request the following information about each of your child's classroom teachers:

- Whether the teacher meets the state qualifications and licensing criteria for the grades and subjects he or she teaches.
- Whether the teacher is teaching under emergency status because of special circumstances.
- The teacher's college major, whether the teacher has any advanced degrees, and the field of discipline of the certification or degree.
- Whether paraprofessionals provide services to your child, and if so, their qualifications.

Liberty School District is committed to providing quality instruction for all students. It does so by employing the most qualified individuals to teach and support each student in the classroom. 
# **Notice for Directory Information**

The Family Educational Rights and Privacy Act (FERPA) requires that Liberty School District, with certain exceptions, obtain your written permission prior to the disclosure of personally identifiable information from your child's education records. However, Liberty School District may disclose appropriately designated "directory information" without written consent unless you have advised the District to the contrary in accordance with District procedures. The primary purpose of the directory information is to allow Liberty School District to include this type of information from your child's education records in certain school publications. Examples include:

- A playbill showing your student's role in a drama production;
- The annual yearbook;
- Honor roll or other recognition lists;
- Graduation programs; and
- Sports activity sheets, such as for wrestling, showing weight and height for team members.

Directory information, which is information that is generally considered harmful or an invasion of privacy if released, can also be disclosed to outside organizations without a parent's written consent. Outside organizations include, but are not limited to, companies that manufacture class rings or publish vearbooks. In addition, federal laws require local education agencies (LEAs) receiving assistance under the Elementary and Secondary Education Act of 1965 (ESEA) to provide military recruiters, upon request, with three directory information categories—names, addresses, and telephone listings—unless parents have advised the LEA that they do not want their student's information disclosed without their prior written consent. If you do not want Liberty School District to disclose directory information from your child's education records without your prior written consent, you must notify the District in writing by September 30. Liberty School District has designated the following information as directory information:

- Student's name
- Participation in officially recognized activities and sports

#### Notification of Rights for Elementary and Secondary Schools

The Family Educational Rights and Privacy Act (FERPA) affords parents and students over 18 years of age ("eligible students") certain rights with respect to the student's education records. These rights are:

1. The right to inspect and review the student's education record within 45 days of the day the school receives a request for access. Parents or eligible students should submit to the school principal a written request that identifies the record(s) they wish to inspect. The school official will make arrangements for access and notify the parent or eligible student of the time and place where the records may be

inspected.

- 2. The right to request the amendment of the student's education records that the parent or eligible student believes are inaccurate or misleading. Parents or eligible students may ask the school to amend a record that they believe is inaccurate or misleading. They should write the school principal, clearly identify the part of the record they want changed, and specify why it is inaccurate or misleading. If the school decides not to amend the record as requested by the parent or eligible student, the school will notify the parent or eligible student of the decision and advise them of their right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the parent or eligible student when notified of the right to a hearing.
- 3. The right to consent to disclosures of personally identifiable information contained in the student's education records, except to the extent that FERPA authorizes disclosure without consent. One exception, which permits disclosure without consent, is disclosure to school officials with legitimate educational interests. A school official is a person employed
- by the school as an administrator. supervisor, instructor, or support staff member (including health or medical staff and law enforcement unit personnel); a person serving on the School Board; a person or company with whom the school has contracted to perform a special task (such as an attorney, auditor, medical consultant, or therapist); or a parent or student serving on an official committee such disciplinary or grievance a committee, or assisting another school official in performing his or her tasks. A school official has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibility. Upon request, the school discloses education records without consent to officials of another school district in which a student seeks to enroll.
- 4. The right to file a complaint with the US Department of Education concerning alleged failures by the school to comply with the requirements of FERPA. The name and address of the office that administers FERPA are: Family Policy Compliance Office, U.S. Department of Education, 400 Maryland Avenue SW, Washington, D.C. 20202-4605.
